**Eligibility:** Service area consists of the four consortium tribal member communities within the four reservations (Cahuilla, Los Coyotes, Santa Rosa, and Torres Martinez) as well as the surrounding communities of Riverside County, San Diego County (North), and parts of San Bernardino County. Additionally, services may be provided to non-native people in these service areas based on availability of funding.

**Program details:** Based on availability of funding, services include emergency short term and basic needs, emergency sheltering, transitional housing, transport/public transportation assistance, small home repair and locksmith (limited), burial/funeral assistance (limited), advocacy, and therapy. Also advocates and assists victims of domestic violence, sexual assault, stalking, and human trafficking.

**Eligibility:** Child may qualify if they: (1) are under 21 years old (2) have a health problem that is covered by CCS (3) are a resident of California **and** (4) have one of the following:

- Family income of \$40,000 or less
- Out-of-pocket medical expenses expected to be more than 20% of family's adjusted gross income
- A need for an evaluation to find out if there is a health problem covered by CCS
- Was adopted with a known health problem that is covered by CCS
- A need for the Medical Therapy Program
- Medi-Cal, with full benefits

**Program details:** CCS is a state program for children with certain diseases or health problems. Through this

program, children up to 21 years old can get the healthcare and services they need. CCS will connect you with doctors and trained healthcare professionals who know how to care for your child with special healthcare needs.

**Eligibility:** Free representation in areas of federal Indian law to Native American individuals who are at or below the federal poverty level. Individuals must meet with an Intake Specialist to determine eligibility. CILS may represent clients in a fee-for-service capacity at a lower-than-market rate.

**Program details:** California Indian Legal Services provides individuals and tribes with legal services pertaining to federal Indian law. Individual matters handled include discrimination based on race, unsealing birth records, domestic violence protection and support, expungement, and legal assistance on Native American jurisdictional issues.

Banning Site (Riverside County) serves eligible Native American families who: (1) reside on the Morongo Reservation and are members/descendants of a Federally recognized tribe or of the California Judgement Roll (2) are Morongo Descendants residing on the Morongo Reservation or in the off-reservation areas of Riverside County, excluding the city of Riverside **or** (3) are enrolled Morongo Tribal members

San Bernardino Site (San Bernardino County) serves eligible Native American families who: (1) reside in the off-reservation areas of San Bernardino County and are members/descendants of a Federally recognized tribe, Alaska Natives, or members/descendants of the California Judgement Roll **or** (2) are enrolled Morongo Tribal members residing anywhere in San Bernardino County.

**Eligibility:** Meet income guidelines (200% Federal Poverty Level). Countable resources cannot exceed \$10,000 per family. Native/Non-Native parent(s) with an eligible minor child. \*Expectant Native parent may be eligible in the third month of pregnancy. Caretakers with eligible Native American child(ren) in the household that meet the above criteria may apply.

**Program details:** MTTP provides a variety of services based on eligibility. Services include cash assistance, supportive services (child care, transportation assistance, work supports, job development services, education assistance, and incentives, and prevention programs (literacy, fitness, parenting, Native American culture and traditions, etc.)

Community food program that assists those in transitional housing as well as local non-profit partners. Resource referral center. Diving Discount and Thrift Store which prepares transitional housing clients for future work in retail.

**Eligibility:** For WIC, see eligibility guidelines in general state WIC entry. For all other services, eligible Native American patient. The Patient Registration Department is responsible for determining whether a person is eligible for Direct Care clinic services and if they are eligible for Contract Care benefits or Purchase Referred Care benefits. Eligibility is determined by providing required documents.

**Program details:** In addition to WIC benefits (see WIC entry), Food and Nutrition program includes registered dietitians, nutritionists, and certified nutrition educators who offer nutrition coaching/classes, senior nutrition services, and commodities food distribution (must be an eligible low-income Native American household for food distribution)

**Eligibility:** (1) Enrolled members of a Federally recognized tribe, members of a tribe identified on the California Judgement Roll, and their descendants. At least one member of the household is required to be Native American. Have a minor dependent child in the home. Individuals expecting a child may be eligible in their third trimester of pregnancy. (2) Reside within the city of Riverside, on the Soboba, Santa Rosa, or Cahuilla Indian Reservations. All Soboba and Santa Rosa tribal members and descendants reside in Riverside County. (3) Meet federal poverty income guidelines.

**Program details:** Soboba Tribal TANF provides a variety of services based on eligibility. Services include cash assistance, support services, career development, resource referrals, and prevention activities.

**Eligibility:** For emergency food bags, a self-certification form must be completed and provide proof of income. Must have qualifying family income. Volunteer youth, young adults, seniors, individuals with disabilities, veterans, and those in recovery programs or needing community service hours eligible for work development programs.

**Program details:** Every week, local food pantries, other nonprofit agencies providing hunger relief, and faith-based organizations pick up pallets of food at the Western Eagle drive-thru and transport to distribution sites in the outlying and rural areas of Riverside County and San Diego County. Western Eagle Foundation is able to offer low to moderate income families an “emergency” food bag of staples (canned and dry goods). Emergency food bags are distributed twice a month, and dates are posted both in weekly communications and social media. Customized food boxes are distributed to families each week and additionally provide a choice of breads, fresh vegetables, fruits, and proteins to offer a nutritious food box to families daily. Work development to increase skill set in stocking, packing, shelving, sorting, pricing, cashiering, customer service, work ethics, and business policies and procedures.

### WOMEN, INFANTS AND CHILDREN (WIC)

For WIC: Meet income guidelines (185% Federal Poverty Level) and be in any of the categories below:

- A pregnant woman
- A woman breastfeeding a baby under 1 year of age
- A woman who had a baby or was pregnant in the past 6 months
- A baby up to their first birthday
- A child up to their fifth birthday
- Babies and children cared for by their fathers, other guardians, or foster parents

**Program details:** The Women, Infants and Children (WIC) Division administers the California WIC program. This program helps families across the state by providing nutrition education, breastfeeding support, healthy foods, and referrals to healthcare and other community services.

For children 0-3, must have a developmental delay of at least 25% in one or more areas of cognitive, receptive communication, expressive communication, social, emotional, adaptive, motor, vision, or hearing development OR have an established risk condition of known etiology OR be considered a risk of having a substantial developmental disability. For 3+, must have a developmental disability which can include autism, cerebral palsy, etc. that is expected to continue indefinitely, originate prior to 18, and be a substantial disability.

**Program details:** Services provide support to families with children that have developmental disabilities, Services given are dependent on the child based upon guidance from an assigned Service Coordinator.
